Industry Partner	<ul style="list-style-type: none">⇒ An Industry Partner is an individual or a company who contributes to DDI.⇒ Industry Partners contribute to DDI either with cash donations, in-kind donations, pro-bono or volunteering of their time.⇒ Industry Partners are listed on the DDI Website, with a link to their company.⇒ Cash and In-Kind Donations are tax-deductible.
Community Business Partner	<ul style="list-style-type: none">⇒ A Community Business Partner (CBP) sells products or offers other services that the local design community utilizes.⇒ CBPs agree to offer DDI Members a discount on their products or services. 10% is the standard requested discount. CBPs may set a minimum purchase for the discount to apply.⇒ Community Business Partners are listed on the DDI Website, with a link to their company.
Advisory Services Partner	<ul style="list-style-type: none">⇒ An Advisory Services Partner (ASP) is an individual who provides advisory services at a reduced rate for a limited time to DDI Members in their area(s) of expertise.⇒ ASP's have a minimum of 20 years professional experience in the areas of counsel they offer.⇒ ASP's are listed on DDI's Website, with their photo, bio and areas of specialty.⇒ ASP's receive engagements for their council from DDI and are paid for their time by DDI.
Event Sponsor Partner	<ul style="list-style-type: none">⇒ An Event Sponsor Partner (ESP) donates resources and/or cash to sponsor DDI events.⇒ ESPs are listed on all flyers, emailers and other documentation for the

event they are sponsoring.

⇒ ESPs receive signage and other recognition at the event they are sponsoring.

⇒ Donations are tax-deductible.

⇒ Event Sponsors receive 2 free tickets to the event they are sponsoring.
